



## 2010 Contingency Program Information



**Company Description:** RECARO - Professional seats for motorsport have a long tradition at RECARO. The company has enjoyed success in motorsport for over 25 years.

In terms of safety and seat technology, **RECARO's** experience in this field offers a development lead, which all classes of world-leading drivers use to achieve success. This knowledge from the world of motorsport is also the basis on which trust for the development of **RECARO** seats for passenger cars, commercial vehicles and child seats is built.

**Program Details:** RECARO USA will provide **two (2) RECARO ProRacer Hans SPG seats with side mounts** with a total value of \$4,400 to Rally America to give away to one (1) winner through a random drawing following the final rally of the 2010 Rally America National Championship – the New England Forest Rally, July 16-17, 2010.

To participate in the year-end drawing, each entrant must agree to not display another seat manufacturers decals on the exterior of their rally car and they must display **RECARO** decals on each side of their rally car just below the rear side windows. In addition, if a competitor decides to use a seat (or seats) other than **RECARO**, the name and/or logo of the seat manufacturer must not be visible when looking in the driver's and/or co-driver's windows – if the manufacturer's name and/or logo is visible, it must be covered.

If the above requirements are met by the competitor, registered participants in the **RECARO** Contingency Program will receive one (1) entry to the year-end grand prize drawing for each Rally America National Rally (or Rally America Regional Rally that's hosted on a Rally America National Rally event weekend) they enter starting at the 100 Acre Wood Rally in Salem, Missouri, February 26, 2010 for a maximum of five (5) entries. One (1) entry per event weekend for each entrant is allowed per Rally America National Championship weekend - this includes multiple Rally America Regional events held on one Rally America National Championship weekend (one entry only).

In addition to up to a max of five (5) entries placed into the year-end drawing, all registered **RECARO Contingency Program** participants will receive an immediate **25% discount** towards the purchase of all **RECARO** seats and/or seat products purchased through **Ed Hessel, Sales Manager – Aftermarket Division, RECARO, USA.**

**Program Registration:** All vehicles must register prior to the start of the event. All vehicles entered must use the supplied **RECARO** decals whether in the National or Regional events. Only vehicles with **RECARO** decals and who have registered in advance of the start will be entered in the year-end drawings. All awards will be distributed at the Awards Banquet following the New England Forest Rally, July 16-17, 2010. Winners do not need to be present at the time of the award.

One (1) **RECARO** decal must be placed below the side rear window on each side of the body of the rally car as close to the bottom of the rear side windows as possible (not on the glass). It is the rally team's responsibility to properly and neatly apply the two (2) **RECARO** decals. Any damaged or obstructed decals will nullify participation in the **RECARO** contingency program. Rally America will verify decal placement prior to the start of the rally - at Tech Inspection or Parc Expose.

Participants in the RECARO Contingency Program are not permitted to have competing seat manufacturer's sponsors or decals visible on the rally car and when looking in the driver or co-driver windows, another seat manufacturer's logo must not be visible.

The required **RECARO** decals are provided to registered participants by Rally America and will be available during Tech Inspection at each of the Rally America events listed above.

Failure to install the required decals prior to the start of the rally will forfeit eligibility.
